Membership will renew automatically at the end of the one-year period on a monthly basis until receipt of written notice of resignation is received by Membership staff and all membership cards are returned to the Spokane Club.								
•	Members are responsible for dues of the next billing cycle after the written resignation is received and acknowledged in writing. The balance due needs to be paid in full to complete the resignation process (Initial)								
•	Accounts not paid within 30 days are subject to a cumulative finance charge, and that nonpayment of accounts may result in col-lection procedures and additional fees. Venue of such action may be Spokane County, Washington at the discretion of the Club.								
•	In accordance with Club bylaws, a member whose account is 90 days delinquent twice in one calendar year will be reviewed by the Membership Committee for possible expulsion.
